SOURCE WATER PROTECTION PROGRAM UPDATE

Andrew McIntyre gave a presentation updating the Board on the Source Protection Program. He informed the Board the Trent Conservation Coalition (TCC) has a new program coordinator – Keith Taylor - who has brought lots of experience to the program. Andrew updated the Board on some technical rule changes and informed them Risk Management Plans (RMP) have received a two-year extension. Some memberships of the Source Protection Committee (SPC) members have expired and some of the members have renewed their membership while other members have been replaced. The SPC has resolved most of the policy challenges with the exception of road salt and pathogens from agriculture. Andrew informed the Board the Municipal Working Group will be meeting sometime in May 2021.

A new online reporting system was implemented for annual reporting this year. The new system proved very helpful especially due to COVID-19 restrictions. Any outstanding implementation is related to RMPs which just received a twoyear extension. The overall score for the TCC Source Protection Region in achieving the objective of the Source Protection Plan is progressing as anticipated and on target.
