SOURCE WATER PROTECTION PROGRAM VERBAL UPDATE

Vicki Woolfrey referred to the minutes of the previous meeting about the CV SPA's request that the Ministry of the Environment and Climate Change (MOECC) simplify the process for selecting new Source Protection Committee (SPC) members. Vicki informed the Board that Chris Wilkinson, Trent Conservation Coalition Project Coordinator, sits on the provincial working group for Source Water Protection Program updates and that he will be bringing this request forward to the Ministry on behalf of all Source Protection Authorities in the Trent Conservation Coalition Region.

Vicki informed the Authority that the next SPC meeting will be March 21, 2017. CV SPAs new SPC member, George Offshack, will be attending the meeting. Vicki and a regional representative met with Mr. Offshack to provide an orientation prior to the SPC meeting.

Vicki will begin the process of reinstating the Municipal Working Group and will be requesting municipalities for staff representation on the Municipal Working Group. The Municipal Working Groups are considered to be an extension of the regional Source Protection Committee (SPC). Their main role is to provide a forum for information exchange between the municipalities and the regional Source Protection Committee. It is anticipated that the Municipal Working Group meeting will be held in late May or June.

SOURCE WATER PROTECTION ANNUAL REPORTING ON THE TRENT SOURCE PROTECTION PLAN

Vicki informed the Board that Annual Reports on the Trent Source Protection Plan have been received and summarized for 2016. Every policy in the Trent Source Protection Plan has an associated monitoring policy that requires annual reporting on the implementation of the policies within the Source Protection Plan.

Vicki reviewed the highlights of the annual reporting with the Board. There have been no compliance issues for 2016. All implementing bodies have reported and are taking actions to implement the policies within the Trent Source Protection Plan by the required timelines.

Next year, in addition to the CV SPA receiving all reports from implementing bodies, the CV SPA and Trent Conservation Coalition Region will be responsible for creating an Annual Progress Report for submission to the MOECC by May 31st, 2018.

Emma Kearns arrived at 10:15am.

There was some discussion on septic systems, the building code and multiple new developments hooking up to municipal sewer systems when available. Vicki will look into the policy further regarding septic systems and municipal sewer hookup.

Vicki reviewed the highlights on implementation efforts surrounding education and outreach, signage, emergency response, septic inspections and storage of fuels.

Tim informed the Board that there will be a slight reduction in SWP funding for 2017-18. CVCA will be reduced from .54 FTE to .52FTE. Vicki informed the Board that the Source Protection Municipal Implementation Fund has been extended until December 2017.
