Tim informed the Board some of the requirements for Regulation 041/24 cannot be met at this time such as providing online mapping on CVCA's website. He would like to see the Board approve the proposed Watershed Planning & Regulations Policy Manual changes and then if necessary make additional changes at a subsequent meeting to ensure compliance with the Ontario Regulation 041/24.
