**RE:** Risk Management Official Contractual Services

## **Key Issue:**

The Risk Management Official for Havelock-Belmont-Methuen (HBM) Township and the Municipality of Highlands East (HE) has resigned from her position, leaving HBM and HE without a designated Risk Management Official. With a trained Risk Management Official on staff, Crowe Valley Conservation Authority has submitted a proposal in the form of a contractual agreement to offer these services in late 2015 through to early 2017 to HBM. Likewise, a proposal will be submitted to HE within the month of September to offer the same Risk Management Official services. Nearly all costs associated with the proposal are eligible for provincial funding through grants the Township and Municipality have received under the Source Water Protection Municipal Implementation Fund (SPMIF).

This technical memo will summarize the services offered as well as the cost and staff time associated for these services.
